

Selfridge Travel — Ultimate Travel Cleaning Kit + \$50 Amazon Gift Card Giveaway: Official Rules

1. Sponsor

The sponsor of this giveaway is **Selfridge Travel, LLC**, Ellinwood, Kansas ("Sponsor").

2. Promotion

The **Selfridge Travel Ultimate Travel Cleaning Kit + \$50 Amazon Gift Card Giveaway** ("Giveaway") is a random-drawing sweepstakes conducted by Sponsor and promoted through Sponsor's website and social-media accounts, including Facebook, Instagram, X, and Google Business Profile ("GBP").

3. Entry Period

The Giveaway begins at **12:00 a.m. Central Time on August 22, 2026**, and ends at **11:59 p.m. Central Time on September 30, 2026** ("Entry Period").

Sponsor's computer is the official timekeeping device. Entries received before or after the Entry Period are void.

4. Eligibility

The Giveaway is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry.

Employees, officers, directors, agents, and representatives of Sponsor, as well as their immediate family members and individuals residing in their households, are not eligible to enter or win. "Immediate family members" includes spouses, parents, children, siblings, grandparents, grandchildren, and their respective spouses.

The Giveaway is void where prohibited or restricted by law. Sponsor may require proof of eligibility, age, identity, and residency before awarding the prize.

5. How to Enter

To enter, an eligible individual must complete and submit the short entry form available at:

The entry form must be completed and submitted during the Entry Period. Required information must be accurate and complete. Incomplete, inaccurate, late, or illegible entries may be disqualified.

There is a limit of **one (1) entry per person** during the Entry Period. Multiple entries submitted by the same person, including entries submitted using multiple email addresses, telephone numbers,

identities, or accounts, may be disqualified. Entries generated by scripts, bots, automated systems, or other technological means are void.

No purchase or payment is necessary to enter or win. A purchase will not increase an entrant's chances of winning.

The Giveaway entry form is separate from any marketing-consent request. An entrant is not required to consent to receive marketing communications in order to enter or win. Any marketing-consent checkbox must be separate, clearly labeled, and unchecked by default.

6. Prize

One (1) winner will receive:

The total Approximate Retail Value ("ARV") of the prize is **\$100**.

The Amazon.com gift card is subject to Amazon.com's applicable terms and conditions. Amazon.com is not a sponsor or administrator of this Giveaway.

The winner is solely responsible for all federal, state, and local taxes and any other costs or expenses associated with accepting, possessing, or using the prize that are not expressly stated in these Official Rules.

No more than the stated prize will be awarded. If circumstances result in more than one potential winner being selected, Sponsor may conduct an additional random drawing from the eligible entrants involved to determine the winner.

7. Winner Selection

One (1) potential winner will be selected by random drawing on or about **October 3, 2026**, from all eligible entries received during the Entry Period.

The odds of winning depend on the total number of eligible entries received.

The drawing will be conducted by Sponsor or its designated representative. Sponsor's decisions regarding the Giveaway, including eligibility, entry validity, drawing procedures, and prize awards, are final and binding to the fullest extent permitted by law.

8. Winner Notification and Claiming the Prize

The potential winner will be notified using the contact information provided on the entry form.

Sponsor will make the first notification attempt by email. If the potential winner does not respond, Sponsor will make a second notification attempt by telephone approximately one (1) week later. If the potential winner does not respond after the second notification attempt, declines the prize, cannot be reached, is determined to be ineligible, or fails to timely provide information required by Sponsor, the potential winner will forfeit the prize.

If the prize is forfeited, Sponsor will select a replacement potential winner by a random redraw from the remaining eligible entries. The replacement potential winner will be contacted immediately by telephone and email using the contact information provided with the entry.

Before receiving the prize, the potential winner may be required to sign and return an affidavit of eligibility, a liability release, and, where legally permitted, a publicity release. If required documents are not returned within the time specified by Sponsor, the prize may be forfeited and awarded to an alternate winner.

Entering the Giveaway does not require an entrant to opt in to marketing communications. Any consent to receive marketing emails, telephone calls, or SMS messages must be obtained through a separate, clearly labeled checkbox that is unchecked by default.

Marketing consent is not required to enter or win. Entrants may withdraw marketing consent at any time by following the unsubscribe instructions in an email or by replying **"STOP"** to an SMS message. Message and data rates may apply to SMS communications.

11. General Conditions

Sponsor reserves the right to cancel, suspend, modify, or terminate the Giveaway, or any portion of it, if fraud, technical failure, unauthorized intervention, human error, or any other circumstance compromises or may compromise the integrity, security, fairness, or proper operation of the Giveaway.

If the Giveaway is canceled, suspended, or modified, Sponsor may select the winner from among all eligible entries received before the action was taken, if feasible. Sponsor is not responsible for any prize or entry-related obligations affected by circumstances beyond its reasonable control.

Sponsor reserves the right to disqualify any individual who tampers with the entry process, violates these Official Rules, attempts to enter using fraudulent or deceptive methods, provides false information, or acts in a disruptive, abusive, threatening, or unsportsmanlike manner.

Entries become the property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, delayed, misdirected, incomplete, corrupted, unintelligible, or improperly submitted entries.
